“ANALYSIS OF BROWNFIELDS CLEAN-UP ALTERNATIVES (ABCA) REPORT FOR BROWNFIELDS PUBLIC LAND SITE IN PINA, TINIAN, FOR THE DEPARTMENT OF PUBLIC LANDS, REAL ESTATE DIVISION”

Due to the anticipated threat of Typhoon Mangkhut, Governor Ralph DLG Torres had declared Typhoon Condition 1 and had shut down all government offices on September 10, 2018 and September 11, 2018. Therefore, this Addendum is issued to schedule the new submission and opening dates for on-island proposers and off-island proposers.

- Sealed proposals must be marked RFP18-DPL/RED-133 – Analysis of Brownfields Clean-up Alternatives for the Masalog Ammunition Depot, Pina, Tinian, CNMI. For proposers within the CNMI, one (1) original and five (5) copies of sealed proposals must be submitted to the Director of Procurement and Supply located at the former Emergency Management Office, Ascencion Drive, Building No. 1301, Capitol Hill, Saipan, no later than 09:00 a.m., ChST, September 10, 2018 **is changed to read 09:30 a.m., ChST, September 17, 2018.**
- Proposers located outside the CNMI may obtain an additional seven (7) working days for receipt of their proposals by submitting a Notice of Intent to submit. Notices of Intent to submit must be received by the Director of Procurement and Supply no later than 09:00 a.m., ChST, September 10, 2018 **is changed to read 09:30 a.m., ChST, September 17, 2018,** and may be made in any mode of written communication including facsimile to (670) 664-1515 or via e-mail to procurement@cnmidof.net.
- For proposers located outside the CNMI, one (1) original and five (5) copies of sealed proposal must be postmarked by the U.S Postal Service or the official government postal service of a foreign country no later than September 10, 2018 **is changed to read no later than September 17, 2018** and may be mailed to the Office of the Director of Procurement and Supply at P.O. Box 510008 C.K., Saipan MP, 96950 and must be received no later than September 18, 2018 **is changed to read no later than the close of business September 26, 2018.**

The provisions of the CNMI Procurement Regulations, NMIAC Section 70-30.3-725 and 70-30.3-730 prohibiting Gratuities, Kickbacks, and Contingent Fees shall apply.

The CNMI Government reserves the right to reject any or all bids or portions thereof, and waive any immaterial defects if to do so would be in the best interest of the CNMI government.
