“24-HOUR ARMED SECURITY GUARD AND PATROL SERVICES AT THE RACE TRACK, SWIMMING POOL, AND GOLF DRIVING RANGE (A) HOTEL, VILLAS, COTTAGES, AND THE MINI GOLF COURSE (B), AND THE GOLF COURSE (C) FOR THE DEPARTMENT OF PUBLIC LANDS, REAL ESTATE DIVISION”


Due to the anticipated threat of Typhoon Yutu, Governor Ralph DLG Torres had declared Typhoon Condition 1 and had shut down all government offices on October 24, 2018 through October 26, 2018. Therefore, this Addendum is issued to schedule the new submission and opening dates for on-island bidders and off-island bidders.

- Sealed bid submittals for this project must be submitted with **one (1) original and three (3) copies** to the Office of the Director of Procurement and Supply located at the former Emergency Management Office, Ascencion Drive, Building No. 1301, Capitol Hill, Saipan no later than 09:00 a.m., local time, October 29, 2018 is changed to read **no later than 09:00 a.m., local time, November 07, 2018** and must be marked **ITB19-DPL/RED-003 (A-C)**.
- Bidders outside the Commonwealth must notify the Director of Procurement and Supply, in writing, of their intent to submit a Notice of Intent to Bid in order to receive this additional seven (7) working days for the receipt of the actual bid documents. This Notice of Intent to Bid may be any mode of written communication including facsimile to (670) 664-1515 or e-mailed to procurement@cnmidof.net but must be received no later than 09:00 a.m., local time, October 29, 2018 is changed to read **09:00 a.m., local time, November 07, 2018**.
- Bids submitted by firms outside the Commonwealth must be postmarked by the U.S. Postal Service or the official government postal service of a foreign country by October 29, 2018 is change to read **November 07, 2018** and mailed to the Office of the Director of Procurement and Supply to P.O. Box 510008, C.K., Saipan, MP 96950 and the bid documents must be received at the Office of the Director of Procurement and Supply no later than November 08, 2018 is changed to read **November 16, 2018**.

- Bids will be publicly opened and read at the Division of Procurement and Supply located at the former Emergency Management Office, Ascencion Drive, Building No. 1301, Capitol Hill, Saipan, at 09:00 a.m., local time, November 09, 2018 is changed to read **09:00 a.m., local time, November 20, 2018**. However, if no Notice of Intent to Bid are received from bidders outside the CNMI, bids will be opened at 09:00 a.m., local time, October 29, 2018 is changed to read **09:00 a.m., local time, November 07, 2018**.

The provisions of the CNMI Procurement Regulations, NMIAC Section 70-30.3-725 and 70-30.3-730 prohibiting Gratuities, Kickbacks, and Contingent Fees shall apply.

The CNMI Government reserves the right to reject any or all bids or portions thereof, and waive any immaterial defects if to do so would be in the best interest of the CNMI government.
